§ 940.19(2) SUBSTANTIAL BATTERY: INTENT TO CAUSE BODILY HARM

[Wis JI-Criminal 1222]

- 1. The defendant caused **substantial bodily harm** to (name of victim).
- 2. The defendant intended to cause **bodily harm** to [(name of victim)] [another person].

PENALTY: Class I felony.

COLLATERAL A "**sexually violent offense**" under § 980.01(6)(b) if sexually motivated. **CONSEQUENCES:**

§ 940.19(4) AGGRAVATED BATTERY: INTENT TO CAUSE BODILY HARM

[Wis JI-Criminal 1224]

- . The defendant caused **great bodily harm** to (name of victim).
- 2. The defendant intended to cause **bodily harm** to [(name of victim)] [another person].

PENALTY: Class H felony.

COLLATERAL A "**sexually violent offense**" under § 980.01(6)(b) if sexually motivated. **CONSEQUENCES:**

§ 940.19(5) AGGRAVATED BATTERY: INTENT TO CAUSE GREAT BODILY HARM

[Wis JI-Criminal 1225]

- 1. The defendant caused **great bodily harm** to (name of victim).
- 2. The defendant intended to cause **great bodily harm** to [<u>(name of victim)</u>] [another person].

PENALTY: Class H felony.

COLLATERAL A "serious felony" under § 939.62(2m)(a)2m.b. ["Three Strikes"]
CONSEQUENCES: A "sexually violent offense" under § 980.01(6)(b) if sexually motivated.

§ 943.24(1) ISSUE OF A WORTHLESS CHECK: MISDEMEANOR

[Wis JI-Criminal 1468]

- 1. The defendant issued a check.
- 2. At the time the check was issued, the defendant intended that it not be paid.

PENALTY: Class A misdemeanor: if the check was for an amount \$2,500 or less.

NOTES: "Check" means an unconditional order to pay money. A check is issued when it is signed and delivered to another. Wis JI-Criminal 1468, notes 2 and 3.

This statute does not apply to a check given for a past consideration, that is, a check given for a preexisting obligation or debt. § 943.24(4).

This statute does not apply to a postdated check. § 943.24(4).

§ 943.24(2) ISSUE OF A WORTHLESS CHECK: FELONY

[Wis JI-Criminal 1469A, 1469B]

- 1. The defendant issued a check.
- 2. At the time the check was issued, the defendant intended that it not be paid.
- 3. The check was for the payment of \$2,500 or more.

OR

Checks were issued within a 90-day period and totaled \$2,500 or more.

PENALTY: Class I felony.

NOTES: "Check" means an unconditional order to pay money. A check is issued when it is signed and delivered to another. Wis JI-Criminal 1468, notes 2 and 3.

This statute does not apply to a check given for a past consideration, that is, a check given for a preexisting obligation or debt. § 943.24(4).

This statute does not apply to a postdated check. § 943.24(4).
