Lan Shapiro, Sterling Professor for Political Science and Professor in the Institute for Social and Policy Studies and of Management at Yale University, will be speaking at the Law School on **Thursday, February 22nd**. Professor Shapiro's talk titled "Democratic Competition: The Good, the Bad, and the Ugly," examines political competition in today's democracies from the voters' point of view. Professor Jason Yackee

Professor Jason Yackee, affiliated with GLS and EALSC, spent the spring semester of 2017 as a Fulbright Scholar at Thammasat University Faculty of Law, in Bangkok, Thailand. He worked on a research project on Thai foreign investment law and policy and co-taught a course on international business transactions. This research was published in a recent book on foreign investment law across Asia. While serving as a Fulbright Scholar, Professor Yackee gave talks on his research at universities in Chiang Mai, Thailand and in Singapore. The UW Law School, through its East Asian Legal Studies Center, has had a long, cooperative relationship with Thammasat University. Professor Yackee was instrumental in establishing an exchange program between the two institutions, which he now directs.
