Carlson Progressive Ideas Forum, UW Law School JD Grants, and Wisconsin Experience Grant.



## Faculty Spotlight

### Professor Mitra Sharafi

GLS affiliate professor Mitra Sharafi is working on a book project entitled "**Fear of the False: Forensic Science in Colonial India**." Between 1840 and 1947, a wave of treatises and institutions emerged to detect crime in South Asia. India's new experts in poison, blood, forgery, and explosives were supposed to cut through the perjury and forgery of "mendacious natives" to extract objective scientific truth in the service of a neutral vision of justice. However, the new forensic science invited increasingly complicated and conflicting answers to the questions, "what is truth?" and "what is justice?" Drawing upon archival research in Delhi and London, Professor Sharafi's study reveals that a system initially structured along fault lines of racial difference morphed into a site for competing conceptions of truth and justice among men of science and of law, both British and Indian. It explores both the opportunities for adaptation and the curtailment of complexity that accompanied forensic knowledge production in the colonial setting.

## Visiting Scholar Spotlight



**Sung-Bae Kim**

### **Sung-Bae Kim, EALSC (February 2018-February 2019)**

Sung-Bae Kim (S.J.D. '07) is a visiting scholar from the Kookmin University College of Law in Seoul, South Korea. His faculty liaison is Professor Steph Tai. During his time in Madison, he will be working on three separate research projects:

- a) The EPA's Role on CERCLA and Land Contamination Regulation - This research project seeks to improve the risk assessment program component of the South Korean Soil Environment Act through comparative study between Korea and the US.
- b) Recent Developments Relating to the Toxic Substances Control Act - This research project looks at EPA regulations and the chemical inventory.
- c) President's Power over Immigration Policy and Application of Laws and Regulations - In the United

States and South Korea, major immigration policies are often set by presidential decree or administrative legislation, not by law. This study examines the recent US immigration policy changes in the Trump Administration and compares this to the situation in Korea.

### **Camilla Reuterswaerd**

Camilla Reuterswaerd is a Law and Society Graduate Fellow from the Political Science Department. Camilla, who is being advised by Professor Aili Tripp of the Political Science and Gender and Women Studies departments, studies gender and politics in Latin America focusing on gender policy reforms in subnational Mexico.
