## Bar Exam Format

Washington is a two-day exam consisting of the Uniform Bar Exam (UBE).

**Day 1:** Six 30-minute Multistate Essay Exam (MEE) questions and two 90-minute Multistate Performance Test (MPT) questions.

**Day 2:** Multistate Bar Exam (MBE), a six-hour, 200-question multiple-choice exam.

## Subjects Tested

**MEE:** Business Associations (Agency and Partnership; Corporations and Limited Liability Companies), Civil Procedure, Conflict of Laws, Constitutional Law, Contracts (including Article 2 [Sales] of the Uniform Commercial Code), Criminal Law and Procedure, Evidence, Family Law, Real Property, Torts, Trusts and Estates (Decedents' Estates; Trusts and Future Interests), and Article 9 (Secured Transactions) of the Uniform Commercial Code. Some questions may include issues in more than one area of law. The particular areas covered vary from exam to exam.

**MPT:** Factual analysis, legal analysis and reasoning, problem solving, identification and resolution of ethical dilemmas, written communication, and organization and management of a legal task.

**MBE:** Civil Procedure, Constitutional Law, Contracts, Criminal Law and Procedure, Evidence, Real Property, and Torts.

**Jurisdiction Specific Component:** Washington Law Component (WLC) is an open-book, timed, online multiple-choice test with Washington-specific study materials available online to review prior to and during the test.
