Bar Exam Format

The Nevada Bar Exam is a 2.5-day exam. Nevada has not adopted the Uniform Bar Exam (UBE).

Day 1: Nevada essay questions prepared by the Nevada examiners and two 2-hour NPT exam questions.

Day 2: Multistate Bar Exam (MBE), a six-hour, 200 question, multiple-choice exam.

Day 3: Nevada essay questions prepared by the Nevada examiners.

***Seven** Nevada Essay Questions between Day 1 and Day 3.

Subjects Tested

Nevada Essay Subjects: Essay examination subjects include a required question on legal ethics as well as the possible following subjects: Agency and Partnership; Community Property; Conflict of Laws; Constitutional Law; Contracts; Corporations; Criminal Law and Procedure; Evidence; Persons and Domestic Relations; Real Property; Remedies; Torts; Uniform Commercial Code (Articles 2 and 9); Wills, Estates and Trusts; as well as pleadings and practices under both the Nevada Rules of Civil Procedure and the Federal Rules of Civil Procedure. Both fundamental legal principles and Nevada law are tested and may embrace more than a single subject. Seven essay questions are asked on the exam.

NPT: Skills tested are factual analysis, legal analysis and reasoning, problem solving, identification and resolution of ethical dilemmas, written communication, and organization and management of legal tasks.

MBE: Civil Procedure, Constitutional Law, Contracts, Criminal Law and Procedure, Evidence, Real Property, and Torts.

MPRE: Applicants are required to take and pass with a score of 85 or higher the Multistate Professional Responsibility Examination (MPRE) within three (3) calendar years before or three (3) calendar years after the examination that an applicant passes (SCR 65.5). This two-hour, 60-question multiple-choice examination is administered three times each year and designed to
