## **Call for Proposals**

Our work in the classroom contributes to and benefits from the communities in which we exist.

We invite you to join us at the Midwest Clinical Conference this fall to celebrate our collective "Clinical Idea" and the ways we all collaborate to benefit legal education and our many communities. Our conference theme is broad, and we welcome proposals of all types: panel discussions, individual or team presenters, paper presentations, or incubator sessions for posing challenging questions or floating ideas and innovations in clinical teaching, service, or scholarship.

We invite new and experienced clinicians, from the Midwest or not, to submit a proposal for the conference!

#### **Conference Session Ideas:**

We invite session proposals that are inspired by the Clinical Idea and collaboration in community. The following examples are meant only as guidance.

- Clinic Student Development and Success Topic ideas may relate to student recruitment, clinical pedagogy, course design or structure, extern/intern guidance and oversight, or student evaluation and assessment.
- Clinics in Context Topic ideas may relate to clinics' positions in legal education, faculty status, clinical scholarship and professional development, faculty onboarding or offboarding, or faculty visibility and outreach.
- Clinics in Community Topic ideas may relate to fostering community relationships, developing practitioner communities, nurturing the interchange of knowledge between clinic and community, collaborating across disciplines, or engaging in social change/movement lawyering.

#### **Incubator Discussion Sessions:**

In addition to regular concurrent sessions, we will host incubator discussions during the conference. These are designed to provide an informal, supportive environment for brief (10-15 minute) presentations on a teaching technique, a scholarship idea, or another project someone hopes to hatch, followed by feedback from other clinicians. Incubator discussion sessions may be related to any of the topic areas mentioned above.

### Conference Schedule:

We anticipate scheduling sessions of various lengths during the morning and afternoon of both Friday and Saturday, November 8 and 9, with a break for lunch. Presenters may choose from the following session lengths: 30 minutes, 60 minutes, or 75 minutes.

## **Submitting a Proposal:**

The deadline for conference proposals is <u>July 31, 2024</u>, and we expect to announce the schedule in early September. If you would like to submit a proposal for more than one session, please complete a separate form for each proposal.
