## **SPEAKER BIOGRAPHIES**



## **KEYNOTE SPEAKER**

Justice Janet C. Protasiewicz was elected to the Wisconsin Supreme Court in April 2023 and took office in August the same year. Prior to her election to the Supreme Court, Justice Protasiewicz served as a Circuit Court Judge in Milwaukee County. She was first elected in 2014 and re-elected in 2020.

While in Circuit Court, Justice Protasiewicz handled a wide variety of cases including homicides, sexual assaults, drug-related offens-



es and domestic violence cases. Her last rotation was in the Family Division, where she handled divorce matters and issues related to child custody and placement disputes.

Justice Protasiewicz proudly served in the Milwaukee County District Attorney's Office for 25 years, where she worked to keep our communities safe. She prosecuted violent crimes, handled termination of parental rights cases and worked to protect children in need of protection and services.

Justice Protasiewicz taught Trial Advocacy at the National Advocacy Center in Columbia, South Carolina, where she taught prosecutors to be the best advocates they could be in the courtroom. She also taught Trial Advocacy at Marquette University Law School and worked as a volunteer grading the Wisconsin Bar exam.

She has received numerous awards including the Community Involvement Award from the Association of Women Lawyers and the Women of Influence Award from the *Wisconsin Law Journal*. She continues to serve the community by working as a volunteer with the Wisconsin Chapter of the American Red Cross, the Polish Heritage Alliance and Marquette University Law School.

Justice Protasiewicz is a magna cum laude graduate of UW–Milwaukee and a graduate of Marquette University Law School.

### **FACULTY SPEAKER**

#### Erin McBride

Professor Erin McBride directs the Government and Legislative Clinic and the Native Nations Externship Program at the Law School and teaches regulatory state and legislative procedure. Through her programs, students have the opportunity to observe and participate in the many facets of governmental law, policy, legislation and tribal governance.



Before joining the Law School, Professor Mc-

Bride was a managing attorney at ABC for Health and served as a managing attorney at Wisconsin Judicare, Inc., where she represented victims of violent crime, testified at the United Nations North American Consultation on Adequate Housing and, in conjunction with the Canadian Bar Association's position on the civil right to an attorney in matters of housing, sued the Canadian government and the Queen of England. She also co-founded (with her twin sister and colleague, Brynne) a free legal clinic/coffeehouse, "Legal Grounds Wisconsin®."

Professor McBride received her J.D. from the University of Iowa College of Law, where she was note and comment editor of the *Iowa Law Review*, and received a B.A. in chemistry and architecture from Bryn Mawr College. Prior to a career in law, she engaged in research and development initiatives as a chemical engineer and was awarded eight U.S. and International Patents for the development of cationic binder polymers.



## STUDENT SPEAKERS

#### Clarence "Kamau" Allen

Clarence "Kamau" Allen was born in Denver, Colorado. He graduated from Howard University in 2017, where he studied political science and African studies. As an undergrad, Kamau participated in "freedom-rides" to Ferguson and Baltimore during the 2014-15 period of civil unrest, where he supported community-led efforts to address police brutality. Since then, he has dedicated his life to



transforming our nation's criminal legal system. Before attending University

of Wisconsin Law School, Kamau pursued his career as a community organizer. He led a campaign in 2018 that reformed Colorado's constitution so that slavery and involuntary servitude could no longer exist as "punishment for a crime." In 2020, he founded the Abolish Slavery National Network to support similar abolition campaigns that succeeded in Utah, Nebraska, Tennessee, Oregon, Alabama, Vermont and Nevada. Kamau's passion for justice reform continued during his time in law school. He co-founded the Fair Sentencing Project, a student organization that supports legislative efforts to eliminate juvenile life-without-parole sentencing. He was also an active member of the Black Law Student Association and a clinical student at the Frank J. Remington Center. He plans to continue his advocacy as a civil rights litigator.

## Duranya Freeman

Duranya Freeman was born in Philadelphia, though she calls many places home, from Maine to Sri Lanka. She graduated from Colorado College in 2018, where she ran track. Before moving to Madison, she worked at the Colorado Center on Law and Policy and the state trial court in Butte County, California. At University of Wisconsin Law School, Duranya was a managing editor of the *Wisconsin Law Review* 



and competed in moot court. She was also the VP of Academic Affairs for the Student Bar Association and a member of the APIDA Law Student Association. She is the recipient of the Bruce F. Beilfuss Memorial Award for service to the Law School, as well as the Catherine Manning Memorial Award and the Clinical Legal Education Association Award for her work with the Legal Assistance to Incarcerated People clinic. After graduation, Duranya will move to Denver to work as an associate at Ballard Spahr LLP.

#### Mohammed Bataineh

Mohammed Bataineh is a Jordanian legal scholar. He is also pursuing a Master's in International Relations at the University of Liverpool. He holds two bachelor's degrees — one in English language and one in law — as well as a Master's in Law from Jordan. His research focuses on constitutional law, particularly the evolution of constitutional reforms in the Middle East. He examines how



these reforms balance social demands with political objectives, using case studies from Jordan, Egypt, Libya, Tunisia and Algeria. His interdisciplinary approach bridges law, politics and governance, aiming to provide insights into institutional reform and democratization efforts. He aspires to contribute to academia, legal reform and policy development, fostering discussions on constitutional law and its role in shaping societies.

### **CEREMONY EMCEE**

#### Dean Daniel Tokaji

Daniel Tokaji is the Fred W. & Vi Miller Dean and Professor of Law at University of Wisconsin Law School. He serves as the chief academic and executive officer of the school, with responsibility for faculty and staff development, personnel oversight, strategic planning and institutional vision, fundraising, budget planning and management, curriculum, and student academic affairs.



Before coming to UW Law five years ago, Dean

Tokaji served on the faculty at The Ohio State University Moritz College of Law from 2003 to 2020; his most recent roles were Associate Dean for Faculty and Charles W. Ebersold & Florence Whitcomb Ebersold Professor of Constitutional Law.

Dean Tokaji has taught a wide variety of courses, including civil procedure, civil rights lawyering, comparative constitutional law, election law and voting rights, federal courts, First Amendment, legal analysis and writing, legislation and regulation, and the U.S. legal system. He has also taught at Harvard Law School, Hong Kong University and Oxford University.

A leading authority in the field of election law, Dean Tokaji's scholarship addresses questions of voting rights, free speech and democratic inclusion. He has published over 50 law review articles, book chapters and other scholarly papers. He is the author of "Election Law in a Nutshell" (2d ed. 2016) and co-author of "Election Law: Cases and Materials" (7th ed. 2022). His recent scholarship addresses the challenges facing democracies around the globe, including the free speech issues surrounding digital disinformation, the need for trustworthy electoral institutions, and the role of law schools in strengthening democratic governance.

Dean Tokaji earned his J.D. from Yale Law School and clerked for the Honorable Stephen Reinhardt of the Ninth Circuit Court of Appeals.

## SPECIAL GUEST

#### Jim Sensenbrenner

Few lawmakers have played a larger role in shaping public policy during the last half-century than Jim Sensenbrenner '68. Sensenbrenner devoted his entire career to public service, first in the Wisconsin State Legislature, then as a Republican member of the U.S. House of Representatives representing a district covering most of Milwaukee's northern and western suburbs.



He served in the House for 42 years, until his retirement in 2021. Among the many highlights of his career in Congress were his leadership in the reauthorization of and amendments to the Voting Rights Act, his many years of work on national security and civil liberties issues and his support of legislation strengthening the Americans with Disabilities Act.

"During his time in public office, Jim demonstrated all the hallmarks of a true American statesman," wrote former Speaker of the House Rep. Paul Ryan in a letter supporting Sensenbrenner's nomination. "He made an indelible mark on our legislative branch, improved our nation's laws in a variety of areas and consistently fought with character, integrity and passion on behalf of the people of Wisconsin."

Sensenbrenner was born in Chicago and shortly thereafter moved to Shorewood, Wisconsin, with his family. He earned a bachelor's degree in political science from Stanford University before returning to Wisconsin for law school.
