SPEAKER BIOGRAPHIES



KEYNOTE SPEAKER

Tammy Baldwin

US Senator Tammy Baldwin has committed her life's work to public service, fighting for fairness, equality, and opportunity because she believes that with each passing year and each generation, our country must become more equal – not less.

Tammy Baldwin was born in Madison and raised by her grandparents in the Badger State. Her grandfather was a scientist at the University of Wisconsin and her grandmother was a seamstress at the university theater company. Baldwin graduated from Madison West High School and went on to double-major in political science and mathematics at Smith College. In 1989, Baldwin proudly received her law degree from the University of Wisconsin, and for over three decades, she has represented the UW at the local, state, and federal level.

She served on the Madison Common Council; was elected to four terms on the Dane County Board of Supervisors; and in 1992, she was elected to the Wisconsin State Assembly, serving three terms. In 1998, Baldwin was elected to represent Wisconsin's 2nd Congressional District. After serving 14 years in the House of Representatives, Baldwin was elected to the Senate in 2012, shattering the state's glass ceiling as Wisconsin's first woman to serve in the Senate and as the first openly gay member elected to the Senate.

Senator Baldwin was reelected in 2018, and serves on the Senate Appropriations Committee. She is the Chair of the Senate Appropriations Subcommittee on Agriculture, Rural Development, and the Food and Drug Administration. In addition, Baldwin is a member of the Senate Committee on Health, Education, Labor, and Pensions (HELP) and the Senate Committee on Commerce, Science, and Transportation.

FACULTY SPEAKER

Miriam Seifter

Professor Miriam Seifter is an Assistant Professor of Law and Rowe Faculty Fellow in Regulatory Law at the University of Wisconsin Law School. Her research and teaching interests include administrative law, federalism, state and local government law, energy law, and property law. Her publications appear or are forthcoming in the Harvard Law Review, the NYU Law Review, the UCLA Law Review, and the Virginia Law Review, among others. In 2017, UW Law students honored Professor Seifter with the Classroom Teacher of the Year Award, and in 2018, she received one of twelve Distinguished Teaching Awards from the University of Wisconsin-Madison. For her article "Gubernatorial Administration," Seifter was named the 2017 winner of the American Constitution Society's Richard D. Cudahy Writing Competition on Regulatory and Administrative Law.

Professor Seifter received a BA magna cum laude from Yale University, an MSc with distinction from Oxford University, and a JD magna cum laude from Harvard Law School, where she was the environmental fellow and an articles editor on the Harvard Law Review. After law school, she served as a law clerk for Chief Judge Merrick Garland on the US Court of Appeals for

the District of Columbia Circuit and for Justice Ruth Bader Ginsburg at the Supreme Court of the United States. Prior to joining the UW Law faculty, she was a visiting researcher and adjunct law professor at Georgetown University Law Center and worked in private practice at Munger, Tolles & Olson in San Francisco.

Yuanyuan Ren

Yuanyuan Ren was born and raised in Yantai, Shandong Province, China. She received her bachelor's degree in law from Shandong Normal University, master's degree in international law from Tongji University, and her Ph.D. degree in international law from Fudan University Law School in China in 2012. She was a Fox International Fellow at the MacMillan Center for Area and International Studies at Yale University from 2010 to 2011.

Before attending UW Law School, she worked as an assistant research professor at the Polar Research Institute of China in Shanghai, where she participated in several international cooperation programs and turned her scholarly attention to polar law. She received her LL.M. degree from UW Law School in 2014 and became an S.J.D. candidate in 2017. Her research interests include public international law, polar law, WTO law, and international dispute resolution. During her time at law school, she served as LL.M./S.J.D. Student Representative on the Student Bar Association from 2014 to 2016 and worked part-time as an LL.M. Discussion Leader for international graduate students. Since August 2020, she has been a post-doctoral Global Fellow at the New York University School of Law.

Yuanyuan is extremely honored to speak on behalf of graduate students and would like to thank all of the law school faculty and staff, her supervisors, families, friends, and fellow classmates who supported her unconditionally.

Brittani Miller

Brittani M. Miller was born in New Rochelle, New York, but considers Greensboro, North Carolina, home. She received her bachelor's degree in history and psychology from the University of North Carolina at Chapel Hill. Prior to law school, Brittani served six years in the United States Air Force as an air traffic control trainee and a paralegal.

During law school, Brittani served as a student ambassador, a competitor in the Constance Baker Mock Trial Competition, and in multiple positions on the executive board for UW Law's Black Law Student Association, including Co-President. Brittani was also an executive board member for the Society for Education Law and Policy and for the Queer Law Students Association. She was also a member of the JD Veterans student group and an ally to other affinity groups within the law school. She was awarded the Bruce F. Beilfuss Memorial Award for outstanding service to the law school in 2020. Brittani is also a member of the Visconsin Association of African American Lawyers, where she was the recipient of the 2020 WAAL VelanDale Scholarship Award. Brittani enjoyed working with the local community, particularly with Tipping the Scales, a program which brings diverse attorneys into Madison East High School to teach high school students about current legal issues.

Catelin Aiwohi

Catelin Kawahinekoa Aiwohi was born and raised in Wailuku, Maui. She grew up primarily on the Paukukalo Homestead, part of the approximately 200,000 acres of land that Congress set aside to establish a permanent land base for the benefit and use of Native Hawaiians. Catelin received her bachelor's degree from Chaminade University of Honolulu. She is also an alumna of the Native American Political Leadership Program at George Washington University and the Washington Internships for Native Students Program at American University.

Prior to law school, Catelin spent several years working in Washington, DC. Most recently, she served as a legislative assistant on the US Senate Committee on Indian Affairs. Catelin also worked in the office of US Senator Brian Schatz and the Office of Hawaiian Affairs. In 2016, Catelin participated in the 'Aha, a constitutional convention of Native Hawaiians, and she worked with roughly 120 participants in drafting a governing document that could be ratified by the Native Hawaiian people.

During her time in law school, Catelin served as Co-President of the Indigenous Law Students Association and competed in the National Native American Law Students Association's Moot Court Competition. She interned with the US Department of Justice in the Office of Tribal Justice and was a summer associate at Dentons. After graduation, Catelin will be starting as an associate at the Washington DC office of Dentons, working with the Native American Law and Policy practice group. Catelin is incredibly honored that her classmates selected her to speak and would like to thank her 'ohana and loved ones for all of their support.
