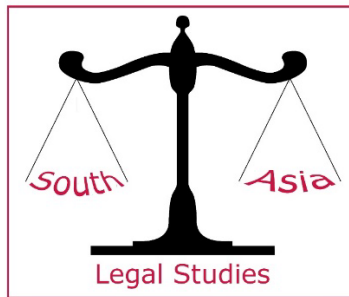


16th Annual South Asia Legal Studies Workshop

2022 SALS Workshop Expectations and Format

Expectations

It is expected that all presenters, commentators and participants will read all the papers and come prepared to make comments. Please make your questions and comments short and succinct. We strive to create a safe and conducive environment for scholarly engagement and discussion so please make sure your comments are given in that spirit.

For each paper we will follow this format

First, the author: Please highlight a few points from your paper, its context or what you would like comments on (5 minutes)

Second, the commentator: Make comments on the paper assigned to you (10 minutes)

Third, we will then open the floor for discussion on the paper. To engage as many people as possible in the time we have, questions and comments are limited to two questions/ comments per person initially (30 minutes).

The moderator will keep the time and a queue of the people in order they raise their virtual hand.

Hand raising function

Many of you will be familiar with Zoom but if you are not:

To indicate you'd like to ask a question or comment, raise your virtual hand. In Zoom the hand raising function is under the reactions tab. The moderator will lower your raised hand and will invite you to speak when s/he reaches your place in the queue.
