Paul **CONNELL**

Professor Paul Connell combines economic models with Al-enabled empirical tools to study law and the deployment of capital. Drawing on his practice experience in capital markets and Ph.D. in economics, he tackles structural questions that cut across doctrine from jurisprudence to foreign investment. His work pairs substantive analysis with the development of rigorous methodologies for integrating Al into empirical research.




Jason **REINECKE**

Professor Jason Reinecke focuses on theoretical and empirical questions in IP and innovation law and policy, with an emphasis on patents. He draws on his experience as a patent litigator and clerk for the U.S. Court of Appeals for the Federal Circuit, alongside his training as a mechanical engineer, to address pressing law-and-policy issues using new data. His findings have garnered extensive citations in high-profile amicus briefs and a leading patent law casebook.

State Democracy Research Initiative (SDRI)

In just four years, SDRI has established itself as the leading nonpartisan resource for legal scholars, judges, legislators and the public for state-level democracy. Its rapid ascent reflects the work of its founders, Professors Miriam Seifter and Robert Yablon, whose scholarship in administrative, election and state constitutional law anchors the project. In 2024-25, SDRI hosted 12 panels and book talks and produced six amicus briefs, six law review articles and 18 white papers and explainers.

Lawyers and Democratic Decline (LADD)

LADD is a new international collaboration studying the role of lawyers and judges in countries facing democratic decline and authoritarian rule. Through comparative research and public-facing events, LADD analyzes how professionals navigate repression, uphold democratic norms and negotiate their professional identity in times of political crisis. Spearheaded by Director Kathryn Hendley, the Roman Z. Livshits & Theodore W. Brazeau Professor of Law and Political Science, LADD maintains an online repository of resources, news and documentation and will host the Wisconsin International Law Journal symposium, "The Role of Lawyers in Backsliding Democracies and Authoritarian Regimes," with attention to the U.S., Brazil, China, Hungary, Israel, Poland and Russia.

Center for the Study of Liberal Democracy (CSLD)

Professor Cecelia Klingele has been appointed director of CSLD, bringing this established UW Center to the Law School. CSLD's mission is to probe the principles, practices and institutions fundamental to liberal democracy, with particular attention to conservative and libertarian political thought. In 2024-25, CSLD convened a reading group, a Constitution Day Celebration and several events featuring legal scholars and lawyers.

His work includes extensive revision to the fair use chapter alongside authoring a new section on generative Al for the leading copyright treatise "Nimmer on Copyright," and his latest articles have appeared in Cornell Law Review, Emory Law Journal, Harvard Journal of Law & Technology, Maryland Law Review, Texas A&M Law Review and Washington & Lee Law Review. This year, he was appointed associate dean for research and faculty development at UW Law.



Pilar **OSSORIO**

Pilar Ossorio, professor of law and bioethics, is a powerhouse in the world of law and science. As an expert in patents and health law with a Ph.D. in microbiology, she has provided policy expertise to significant NIH initiatives while writing extensively on scientific ethics and innovation. Her interdisciplinary scholarship has garnered over 8,300 citations across academic journals.



Anuj **DESAI**

Volkman-Bascom Professor of Law Anuj Desai is an esteemed scholar and expert in cyberlaw, First Amendment, intellectual freedom, and the legislative and administrative process. He serves as chair of the Administrative Law section of AALS and has published in Stanford Law Review, Northwestern University Law Review, Law and Social Inquiry, Federal Communications Law Journal, Journal of Institutional Studies and University of Pennsylvania Journal of Constitutional Law.

Lisa WASHINGTON

Emerging as a leader at the intersections of family regulation and the criminal and immigration law systems, Professor Lisa Washington's work has appeared in Yale Law Journal, Columbia Law Review, Northwestern University Law Review, Boston University Law Review, Chicago Law Review Online and the Yale Law Journal Forum. In Spring 2025, she was voted UW Law Teacher of the Year. Her work also earned the 2024 Dukeminier Award from the Williams Institute and 2025 Emerging Scholar Award from the AALS Family and Juvenile Law Section.

Nathan **ATKINSON**

Professor Nathan Atkinson is a scholar whose research focuses on corporate governance, contract theory and voting procedures. His corporate-misconduct research explores the ways that corporations can profitably break the law and what can be done to stop them. He also investigates how electoral reform could help reduce political polarization. In addition to publishing in flagship law reviews, he has also placed articles in leading economics and management journals.



Mitra **SHARAFI**

Evjue-Bascom Professor of Law Mitra Sharafi is a renowned legal historian whose work focuses on South Asia. She is the president-elect of the American Society of Legal History and was recently awarded the Best Article Prize by the *Indian Law Review*.

David **SCHWARTZ**

Fredrick W. & Vi Miller Professor of Law and Vilas Distinguished Achievement Professor David Schwartz is a prolific constitutional law scholar. His extensive list of scholarly publications and papers, along with his role as the founder and editor-in-chief of the *Journal of American Constitutional History*, have made him a beacon of authority on the Constitution and its history. His work has been cited this year by the U.S. Supreme Court, The New York Times and top legal podcasts.

Joshua **BRAVER**

Professor Joshua Braver has built his reputation on work that analyzes past constitutional conflicts to construct principles for moments when law's boundaries are pushed, stretched or violated. Alongside his scholarship, he brought his current research on military deployment and military disobedience to bear on high-profile debates through opinion essays in The Atlantic and The New York Times.

Emily CAUBLE

Emily Cauble, associate dean for Academic Affairs and the Thomas G. Ragatz chair in Tax Law, is a leading scholar in tax policy and administration. Her co-authored treatise "Understanding Corporate Taxation" has emerged as an essential resource, and her recent articles have explored the way misinformation and misunderstanding impact American taxpayers in surprising areas, from purchasing homes to managing student debt.

Renagh O'LEARY

Professor Renagh O'Leary explores the frontiers of criminal law and procedure, with a focus on sentencing, decarceration and compassionate release. Drawing on years of experience as a public defender and clinical professor, she bridges theory with grounded insights in scholarship that has appeared in *Iowa Law Review*, *UC Davis Law Review*, *North Carolina Law Review* and *Wisconsin Law Review* and has twice earned recognition in the AALS Criminal Justice Section's Junior Scholars Paper Competition.

Franciska COLEMAN

Professor Franciska Coleman integrates political theory, critical discourse analysis and First Amendment law to analyze contemporary speech controversies. She chairs the AALS section on Constitutional Law and serves as chair-elect for the AALS section on Election Law, and her scholarship exploring "cancel culture" has garnered significant recognition.

Mark SIDEL



His deep experience and focus on Asia have made him a highly sought-after expert, with over 20 presentations and speaking engagements in the last year. Sidel was recently elected to the board of directors of Give2Asia, the primary intermediary organization working with U.S. entities seeking to do philanthropic work in China.

Nina **VARSAVA**

Professor Nina Varsava's scholarship on adjudication, procedure, legal ethics and jurisprudence probes deep questions of precedent and interpretation. Recently, her work has appeared in Legal Theory, Harvard Law Review, University of Chicago Law Review, Notre Dame Law Review and the Yale Journal of Law and Humanities. Her scholarship has been covered by The New York Times and the American Bar Association Journal and has been cited by both federal and state courts.
