# Food and Agriculture Competition Roundtable



The American Antitrust Institute (AAI) and the University of Wisconsin Law School are pleased to present the competition roundtable "Food and Agriculture at a Crossroads: Setting Competition Priorities to Protect Producers, Consumers, and the Supply Chain." The roundtable, which will take place from 8:30am - 4:15pm on Friday, December 7th, will discuss major competition policy issues involving concentrated food and agriculture markets, their interconnections to the broader national and global supply chains, and strategies for improving competition. The roundtable will begin with a briefing on the state of competition in food and agriculture,

with a focus on gaps in the law or legal doctrine that makes developing competition policy particularly difficult. The day will feature three panels on topics that have important implications for competition enforcement and policy. Experts in antitrust and regulation from government, industry, advocacy, and academia will frame major competitive issues through the lens of different stakeholder and enforcement perspectives. The morning and afternoon discussions will each close with a roundtable session that gives participants the opportunity to react to and

candidly discuss themes, issues, and policy recommendations for competition enforcement. The roundtable will take place in **Law School Room 2211**.

### Featured Program: South Asia Legal Studies Working Group

In 2006, a working group was established by Professor Mitra Sharafi to coordinate and promote events pertaining to South Asian legal studies and to facilitate intellectual exchange between faculty and students at the University with shared interests in the field. The disciplinary interests of the working group include political science, history, religious studies, and, within law itself, environmental law, human rights, Islamic law, constitutional law, discrimination, women's studies, and the legal profession.



Members of the Working Group have interests and expertise on various aspects of law in South Asia and join long-time UW-Madison Professor Marc Galanter, whose extensive work on law in South Asia has been extremely influential in American and in South Asian scholarship. Law School faculty and staff members of the Working Group include Sumudu Atapattu, Marc Galanter, Mitra Sharafi, Sunil Rao, and Mark Sidel, and SJD students Cynthia Farid and Maryam Khan.

The Working Group hosts speakers and organizes the annual South Asia Legal Studies Workshop, the first and, so far, the only workshop on South Asian legal studies in the United States. Now in its 12th year, the workshop has become a popular inter-disciplinary event among South Asian scholars and graduate students.

### Faculty Spotlight: Kathryn Hendley



**Professor Kathryn Hendley** 

GLS affiliate Professor Kathryn Hendley is a longtime student of legal reform in contemporary Russia. In 2017, she published *Everyday Law in Russia* (Cornell University Press), that explored how ordinary Russians experienced law. It was grounded in focus group research and hundreds of hours of observation of the Justice-of-the-Peace courts, carried out as a Fulbright Scholar in Russia. She has now turned her attention to the legal profession. Thanks to a grant from the NSF, she fielded a 2016 survey of over 2000 graduating law students from 163 different law schools. Hers is the first project to study the Russian legal profession as a whole. To date, scholars have focused on specific types of lawyers, such as prosecutors, licensed litigators, judges, and investigators. Many other types of lawyers, such as unlicensed litigators and lawyers for state agencies, have traditionally been left out of the picture. Looking at Russian lawyers as a whole has allowed her to rethink how we conceptualize lawyers in Russia and other post-Communist countries. Several articles drawn from her data have been accepted for publication and more are in the pipeline. Professor Hendley hopes to be able to field future surveys that

will track her respondents throughout their careers.

## **Visiting Professor Spotlight**

#### Pablo Rueda Saiz, August - December 2018

Pablo Rueda-Saiz is currently a Tinker Visiting Professor at the University of Wisconsin Law School. He is a Colombian lawyer who holds an M.A. and a Ph.D. in Jurisprudence and Social Policy from the University of California, Berkeley. Professor Rueda-Saiz is currently working on a project that explores some of the limitations that social movements encounter when they use legal tactics against powerful global corporate actors, both inside and outside the formal legal process. His current work focuses on the disconnect between social movements and the law. His research also studies how social movements innovate. Professor Rueda-Saiz chose the UW Law School to continue his research because it has a tradition of rigorous socio-legal scholarship and a strong commitment to comparative law. These two aspects of UW Law School are ideal for allowing him to investigate the relationship between law and globalization. In addition to his time at UW Law School, he has taught at the Universidad de los Andes and the Universidad del Rosario in Colombia, and at the University of Giessen U.S.-German Summer Law School. He has published both in English and in Spanish on
