"Agency and Race in the Criminal System," December 5, 2019

Professor Ion Meyn will be hosting "**Agency and Race in the Criminal System**" on Thursday, December 5th. The conference brings together scholars who examine how the criminal system denies agency to the defendant, and how the criminal system works to reflect and reaffirm racial hierarchies.

Discussions will follow the timeline of the criminal system, from the police encounter on the street, to pretrial detention, to pretrial information exchange, and sentencing. A critical lens will be applied, the focus being on how

social, legal, and institutional dynamics have resulted in alarming racial disparities and a system-wide deprivation of defendant's agency to participate in his own case.

Wisconsin Law in Action Podcast



Faculty Spotlight: Ion Meyn

Ion Meyn

Assistant Professor of Law Ion Meyn teaches in the area of civil rights, civil procedure, and criminal procedure. His research examines how the rules that govern litigation can work to reproduce race and class disparities.

His work-in-progress, "The Creation of Separate and Unequal Courtrooms," observes that rules of procedure in the United States were crafted during the Jim Crow era and can be understood to reflect the racial norms of that era. His article, "The Haves of Procedure," contends that to permit "criminal haves" (prosecutors) and "civil haves" (institutional players) to litigate in separate forums confers significant benefits to each. His article, "Why Civil and Criminal Procedure Are So Different," draws on archival material to tell the story of the personalities and interests at play that contributed to the moment of reform in which criminal procedure was segregated from civil procedure.

He serves as the Reporter for the American Bar Association's Standards on Diversion. This multi-year project brings together prosecutors, judges, defense attorneys, and policy experts to recommend procedures to guide the development and implementation of diversion programs. When completed, these standards will provide stakeholders across the country with a template to consider alternatives to traditional criminal justice approaches. He also serves as the Co-Chair to the Academic Committee of the ABA's Criminal Justice Section, which hosts an annual conference in Washington D.C. that brings together criminal law scholars to discuss new areas of research and inquiry.
